<b>KEY DUTIES</b>	<ul style="list-style-type: none"> <li>Advocate on behalf of young people.</li> <li>Advise Puffing Billy Railway on current youth topics and issues.</li> <li>Provide an innovative way of thinking to inform PBR policies, procedures, and programs.</li> <li>Ensure PBR is meeting the needs of young people in our community.</li> <li>Brainstorm ideas on how PBR might reach and engage with more young people in our community.</li> <li>Provide input on how PBR can improve the visitor experience of young people.</li> <li>Assist PBR by evaluating existing programs and creating new ones.</li> </ul>
